Introduction

This document summarizes the services offered by CPT Capital, LLC, dba AstraBit and dba AstraBlox ("Services," "we," "our," or "us") to retail investors as a Broker-Dealer registered with the Securities and Exchange Commission ("SEC"). 1. What services do you provide me?

- a. <u>AstraBit:</u> provides Automated Trading Bots ("Bot") that help you manage your Digital Asset holdings through our site using your own strategies or subscribing to approved third-party custom strategies. Our software provides you with tools that allow you to:
 - i. place buy/sell orders from your Bot that will automatically cause one or several third-party Digital Asset Exchanges to execute transactions from your Exchange Account/Linked Wallet ("Linked Wallet");
 - ii. configure the parameters of your Bot, which will automatically execute Transactions within those established parameters and without the need for additional interaction or intervention;
 - iii. elect to follow and receive additional information from third parties who use the Software as a platform to distribute their own information to users who have subscribed to their feed or distribution list;
- b. <u>AstraBlox:</u> In addition to operating staking, yield farming, and liquidity mining software, AstraBlox engages in SEC-regulated Securities Act Regulation D and Regulation S offerings with Approved AstraBlox Customers. Approved AstraBlox Customers are strictly defined as: (i) Rule 501 Accredited Investor; (ii) Qualified institutional Buyer ("QIB"); (iii) Other Institutional (Non-retal) investor; and/or (iv) Regulation S Non-US Persons.
 - i. **Tokenization (SEC-REGULATED)**: AstraBlox is designed to empower decentralized finance (DeFi) activities, including access to third-party, yield-bearing smart contract vaults for digital asset staking and digital asset swaps. AstraBlox is built to simplify, secure, and optimize DeFi participation for Approved AstraBlox Customers.
 - ii. **Staking** is the process of actively participating in transaction validation on a proof-of-stake ("PoS") blockchain and earning staking rewards for participation in the underlying blockchain's consensus algorithm.
 - iii. **Yield Farming** allows you to stake your digital assets within smart contracts that operate as liquidity pools for Decentralized Exchanges. These staked Digital Assets can then be borrowed, and a passive interest is earned.
 - iv. **Liquidity Mining** involves staking Digital Assets within Liquidity Pools, where a Token and/or governance token are supplied back to the user as a reward for providing liquidity.

c. AstraBit Portfolio Management & Analysis allows you to:

- i. Track and manage your entire portfolio in real-time.
- ii. Gain insights with detailed analytics and performance metrics.
- iii. Identify growth opportunities and manage risks effectively.

2. What DON'T you provide me?

a. <u>No Investment Advice.</u> We do NOT provide financial, investment, business, accounting, tax, legal, or other advice, and you should not treat or rely on our Services as such. We do not recommend that any Digit Asset be bought, sold, held, or traded by you.





- b. <u>No Exchange</u>. We are NOT a Digital Asset Exchange nor a "Money Services Business." We do NOT knowingly buy Digital Assets from you, sell Digital Assets to you, or facilitate such transactions between you and any other of our customers.
- c. <u>No Custody</u>. You cannot store any Digital Assets, flat money, or currency of any kind with us. We are not a custodian, bank, trustee, or otherwise a depository institution. All custody is done through third parties.

3. What fees will I pay?

- a. <u>Credit Account Balance</u>. We make available a prepaid credit balance system (the "Credit Account Balance"), and we require you to use the credits in your Credit Account Balance to purchase our Services, Strategies, etc. ("Credits"). You must provide a Payment Method and authorize us to charge your Payment Method for any Credit Account Balance funds or other fees incurred by you. You are responsible for all purchases made by you or anyone else using your Credit Account Balance.
- b. We will draw down on your Credit Account Balance each day for each Bot and Custom Strategy or other Services that you have subscribed to for such day (collectively, the "Daily Credit Charge"). You may unsubscribe at your discretion at any time.

You will pay fees whether you make or lose money on your investments. Fees reduce the amount of money you make on your investments over time. Please ensure you understand the fees and costs you are paying.
